Ascension Lutheran Church Debit Card Policy

(Revised May 10, 2022)

Debit cards may be made available to staff members with the President's approval. Each employee is responsible for safeguarding his or her card. Should one be lost or stolen, the staff member must contact the Treasurer immediately so the card can be deactivated.

The cards are to be used for church business purchases only. Any personal expenses inadvertently incurred must be reimbursed by the staff member as soon as possible. Each expense over \$100 must be approved by the board chair responsible for the impacted budget either before or within 5 days of the purchase. The card holding staff member will be held accountable for any unapproved purchases. Once the transaction is made, the receipt and the attached debit card approval form (or an email of authorization) must be delivered to the Treasurer within seven (7) days.

Cash withdrawals (ATM) are not allowed except in emergencies. (Note: the limit is \$100 per month and receipts are still required for expenses.)

Purchases are limited to \$500.

Misuse of the card:

First Offense – verbal warning Second Offense – card surrendered for one month Third Offense – card surrendered permanently

Board of Trustees Report to Council May 10, 2022

- 1.0 Office Computer Server Replacement Delay: True Tower Group/ Doug Butte has arranged to implement the move of our data files to the Cloud. We will archive our server. The plan includes the necessary assignment of a new domain named alc-online.info. This domain will permit all staff to have an Ascension email addresses and give them access to the Cloud storage. However, This will also change the Church's Main email address to office@alc-online.info. This change has been delayed because of scheduling issues and technical issues. The current plan appears to be to implement the program for all the staff except Pastor and to train Pastor at a later date.
- 2.0 Cleaning/ House Keeping Position: Lee Valdez has accepted this position to clean the Church for a month. He has been working for two weeks and we will evaluate this agreement soon to determine if he wants to continue.
- 3.0 Security Cameras: A new controller has been installed to monitor the cameras. The old controller lost its power supply. We are now recording the images and have access to them for 5 days. The camera monitor in the main office needs to be brought on-line.
- 4.0 Heat Control Compressor: The motor on the compressor that controls the pneumatic thermostats failed early last week. Pasterkamp Heating and AC ordered a new motor and were able to install the motor Friday afternoon. The total cost was under \$900.00. We still need to replace the valves on two of the register units that are not properly controlled by their thermostats.
- 5.0 Sprinkler Controls: Two of our three Sprinkler Controllers have failed. One that controls the east lawn/ east end of the south lawn and the plants in the parking lot and the other unit that controls the Memorial Garden. Both of these units are older. The Memorial Garden unit was replaced last Saturday and the other new unit will be installed this week.
- 6.0 Outside Lights/ West Wing South side: Denver Electric is scheduled to replace the timer that controls these lights with a light sensor control. The older existing digital controller is finicky and difficult to program and needs to be reprogramed several times per year. We are also looking at replacing the timer controlling the outside lights on the Sanctuary building with another light sensor.
